PSC to Hold Three Public Hearings for Proposed Dakota Access Pipeline

BISMARCK, ND – The North Dakota Public Service Commission (PSC) will hold three public hearings regarding a proposal for the Dakota Access Pipeline. Hearings will be held in Mandan, Killdeer and Williston.

Dakota Access, LLC, has filed an application for the Dakota Access Pipeline. The entire pipeline would run approximately 1,150 miles beginning from the Bakken/Three Forks play in North Dakota through portions of South Dakota and Iowa and ending in Patoka, Illinois. The North Dakota portion consists of approximately 358 miles of crude oil pipeline that increases in diameter incrementally from 12 inches to 20, 24 and ultimately 30 inches.

It is estimated that the pipeline will initially transport approximately 450,000 barrels of crude oil per day, with a maximum capacity of 570,000 barrels per day or greater depending on demand. Six tank terminals are planned along the route: at the starting point near Stanley, south of Tioga, near Epping, near Trenton, near Watford City, and at Johnson's Corner. Estimated cost of the entire project is \$3.78 billion, with nearly \$1.41 billion estimated for the North Dakota portion.

Any comments from members of the public must be received at the hearings to be part of the record. People with concerns, questions or support for the project are encouraged to attend a hearing and present the information. <u>Information received after the hearing will not be part of the official record and cannot be used as a basis for the Commission's decision unless certain additional procedures are followed.</u>

The North Dakota Public Service Commission is a constitutionally created state agency with authority to permit, site and regulate certain business activities in the state including electric and gas utilities, telecommunications companies, power plants, electric transmission lines, pipelines, railroads, grain elevators, auctioneers, commercial weighing devices, pipeline safety and coal mine reclamation.
