## **PSC Schedules Public Hearing for Proposed Wind Farm Project and Associated Transmission Line**

BISMARCK, ND – The North Dakota Public Service Commission (PSC) will hold a public hearing on Monday, January 29, regarding a proposal to construct a wind farm in Oliver County and associated transmission line in Oliver and Mercer Counties.

Oliver Wind IV, LLC (a wholly owned, indirect subsidiary of NextEra Energy Resources, LLC), is requesting a siting permit for the Oliver Wind IV Energy Center and an associated transmission line. The wind project would have a nameplate capacity of up to 200 megawatts and would consist of up to 73 wind turbines and associated facilities. The project area would encompass approximately 22,291 acres in Oliver County. The estimated cost of the project is \$316 million.

The 345 kV electric transmission line would be approximately 19.5 miles long in Oliver and Mercer Counties. The line would convey power from the planned Oliver Wind IV Wind Energy Center to the point of interconnection at the Basin Electric Power Cooperative Leland Olds Station. The estimated cost of the project is \$43 million.

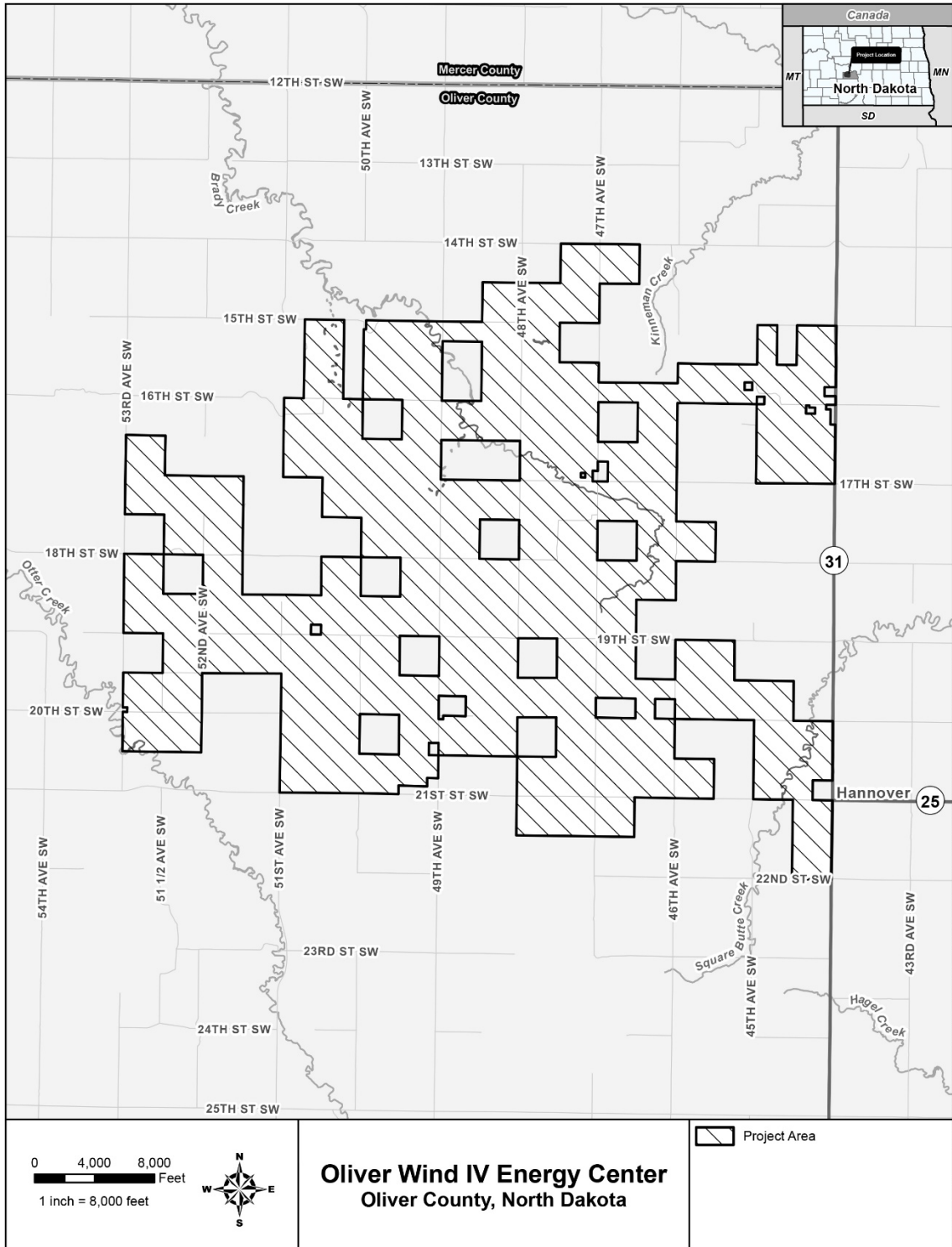

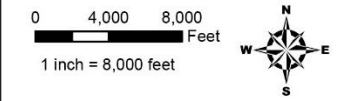
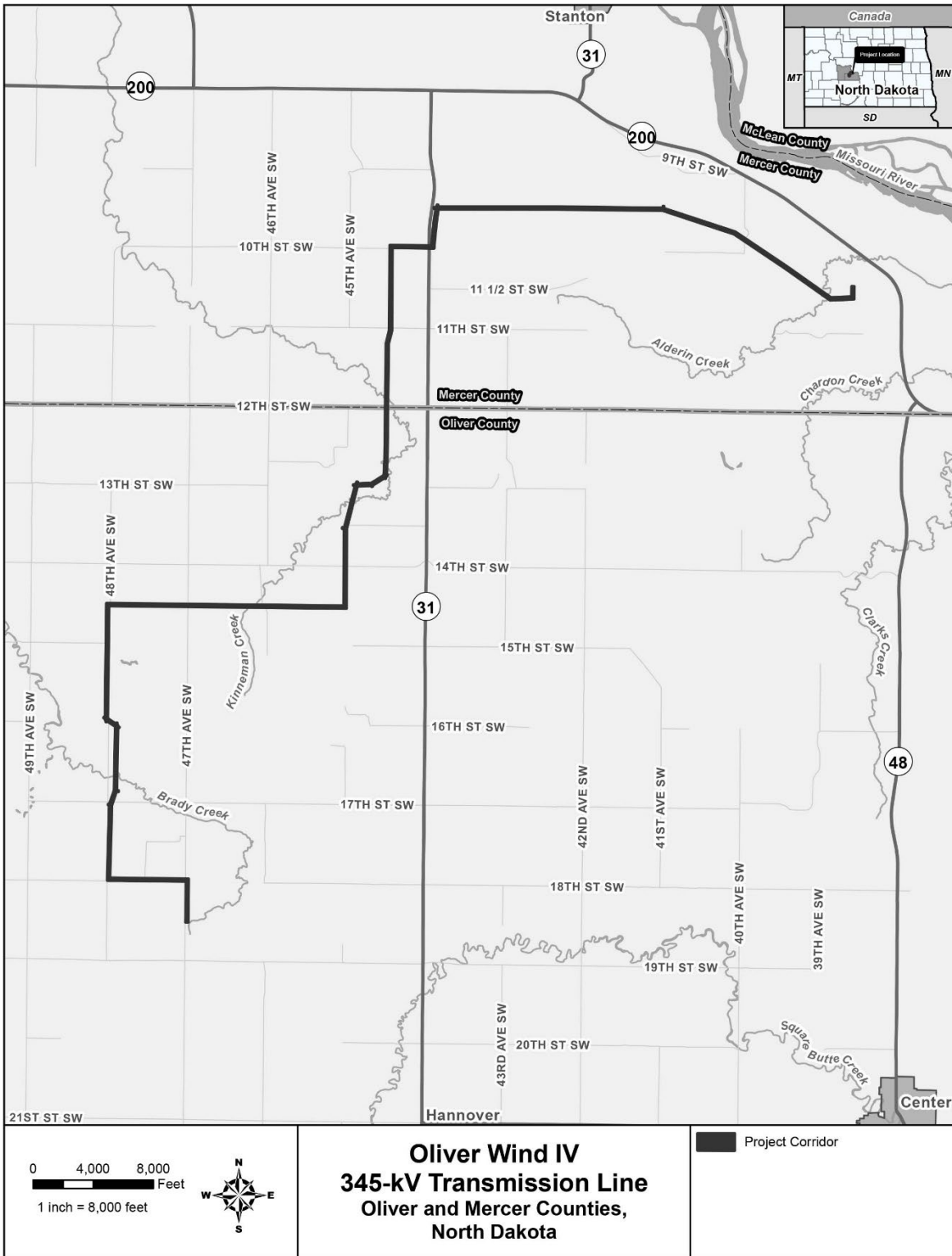
The North Dakota Public Service Commission is a constitutionally created state agency with authority to permit, site and regulate certain business activities in the state including electric and gas
