

**AMENDMENT TO

**This AMENDMENT TO WIRELESS INTERCONNECTION AGREEMENT BETWEEN MOORE & LIBERTY TELEPHONE COMPANY AND CELCO PARTNERSHIP, d/b/a VERIZON WIRELESS (the "Agreement")**, entered into to be effective as of the 1st day of July, 2004, revises the Reciprocal Compensation rate contained in the Wireless Interconnection Agreement between Moore & Liberty Telephone Company and Cellco Partnership, d/b/a Verizon Wireless January 1, 2002.

Effective July 1, 2004, commencing with the automatic renewal of the Agreement for successive six months period, pursuant to Article II, Section 5.1 of the Agreement, the Reciprocal Compensation rate shall be changed to \$0.031 per minute of use.
