

**AMENDMENT No. 2 TO
WIRELESS INTERCONNECTION/COMPENSATION AGREEMENT
BETWEEN GRIGGS COUNTY TELEPHONE COMPANY ("GCTC") AND
CELLCO PARTNERSHIP D/B/A VERIZON WIRELESS**

This Amendment No. 2 (the "Amendment") to the existing Wireless Interconnection/Compensation Agreement between Griggs County Telephone Company ("GCTC") and Cellco Partnership d/b/a Verizon Wireless ("VZW") that was effective January 1, 2002 (the "Interconnection Agreement") is made and entered into as of February 1, 2005 between GCTC and VZW.

WHEREAS, GCTC and VZW (hereinafter individually referred to as a Party or collectively referred to as the "Parties") desire to amend the existing Interconnection Agreement; and

NOW, THEREFORE, in consideration of the mutual provisions contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree as follows:

1. The following language is inserted as new Section 7.7 of the existing Interconnection Agreement:

7.7 SS7 Out of Band Signaling (CCS/SS7) shall be the signaling of choice for interconnection trunks, where it is technically feasible for both Parties. Use of a third party provider of SS7 trunks, for connecting VZW to the GCTC SS7 systems is permitted. Such connections shall meet generally accepted industry technical standards. Any monthly recurring charges for SS7 connectivity billed by GCTC to VZW shall be shared by the Parties according to the Traffic Factor in Section 5.4 above. VZW is responsible for all nonrecurring charges for SS7 connectivity.
