MIDCONTINENT COMMUNICATION'S PETITION FOR APPROVAL OF
AGREEMENT


On October 8, 2007, Midcontinent Communications ("Midcontinent") filed a Petition for Arbitration in this matter. The only issue for arbitration listed by Midcontinent in the petition was the discount rate for the Hettinger, North Dakota exchange of Consolidated Telcom ("Consolidated"). Under date of October 18, 2007, Consolidated filed its Response to Midcontinent's Petition to Arbitrate agreeing that the only open issue for arbitration was the discount rate for the Hettinger, North Dakota exchange. Thereafter, Consolidated agreed to the discount rate suggested by Midcontinent in the petition and the parties voluntarily entered into the ADDITIONAL TERRITORY AMENDMENT TO THE INTERCONNECTION AGREEMENT BETWEEN CONSOLIDATED TELCOM AND MIDCONTINENT COMMUNICATIONS. Said agreement is marked as Exhibit "A" and attached hereto.

WHEREFORE, Midcontinent requests that the Commission enter an order as follows:

- 1) dismissing the arbitration proceeding, and
- 2) approving the ADDITIONAL TERRITORY AMENDMENT TO THE INTERCONNECTION AGREEMENT BETWEEN CONSOLIDATED TELCOM AND MIDCONTINENT COMMUNICATIONS pursuant to 47 U.S.C. § 252(e)(1).

ADDITIONAL TERRITORY AMENDMENT
TO THE INTERCONNECTION AGREEMENT BETWEEN
CONSOLIDATED TELCOM AND MIDCONTINENT COMMUNICATIONS

This Amendment ("Amendment") dated as of January 25th, 2008 is made and entered into by and between Consolidated Telcom ("Consolidated") and Midcontinent Communications ("Midcontinent") (Collectively, the "Parties"). The services described in this Amendment shall be provided in the State of North Dakota.

RECITALS:

WHEREAS, the Parties entered into an Interconnection Agreement for services in the State of North Dakota that was filed with the North Dakota Public Service Commission on August 21, 2007 ("Prior Agreement") and,

WHEREAS, The Parties wish to amend the Prior Agreement under the terms and conditions contained herein.

AGREEMENT

NOW THEREFORE, in consideration of the mutual terms, covenants and conditions contained in this Amendment and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:

AMENDMENT TERMS

The Prior Agreement is hereby amended by adding the Hettinger, North Dakota Exchange to Exhibit B, Area of Resale to Attachment 1, Resale, to the General Terms and Conditions of the Prior Agreement as filed and above mentioned.

EFFECTIVE DATE

This Amendment shall be deemed effective upon approval by the Commission.

ENTIRE AMENDMENT

The Prior Agreement as amended constitutes the full and entire understanding and agreement between the Parties with regard to the subjects of the Prior Agreement as amended and supersedes any prior understandings,

agreements, or representations by or between the Parties, written or oral, to the extent they relate in any way to the subjects of the Prior Agreement as amended.

The Parties intending to be legally bound have executed this Amendment on the dates set forth below, in multiple counterparts, each of which is deemed an original, but all of which shall constitute one and the same instrument.
