Amendment NO. 3  
TO THE WIRELESS INTERCONNECTION AGREEMENT  
BY AND BETWEEN  
NORTH DAKOTA TELEPHONE COMPANY AND  
NORTH DAKOTA NETWORK COMPANY D/B/A SRT WIRELESS

This is an Amendment (“Amendment”) to the Wireless Interconnection Agreement by and between North Dakota Telephone Company (“North Dakota”) and North Dakota Network Company d/b/a SRT Wireless (“NDNC”), jointly the “Parties.”

**RECITALS**

WHEREAS, the Parties, or their predecessors in interest, previously entered into a Wireless Interconnection Agreement (“Original Agreement”), pursuant to 47 U.S.C. §§251 and 252, effective July 1, 2006; and

WHEREAS, the Agreement was amended by Amendment to the Wireless Interconnection Agreement (the “Amendment”) effective November 12, 2007.

WHEREAS, the Agreement was further amended by Amendment No. 2 to the Wireless Interconnection Agreement (the “Amendment”) effective July 1, 2012 and the Amendment has been approved by the North Dakota Public Service Commission.

WHEREAS, the Parties wish to further amend their Agreement and amendments thereto (the “Amendment No. 3”) specifically for the purposes of updating the local calling scope.

NOW, THEREFORE, in consideration of the mutual provisions contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree as follows:

1. Section 4.1 of the existing Interconnection Agreement shall be replaced in its entirety with the following:

4.1 Type 2-A Interconnection at Minot: A two-way trunk group is provisioned between NDTC’s network in Devils Lake, ND (DVLKNDXADSO) and NDNC’s parent network in Minot, ND (MNOTNDXAO1T). Applicable tariff charges for establishing and provisioning this trunk group is billed by NDTC to NDNC.

A. Landline-to-Wireless:

Local Service Area calls from NDTC customers to NDNC’s customers in NDTC’s rate center area under OCN 2577 and listed in Attachment 1 are routed over the two-way trunk from NDTC’s Devils Lake network to NDNC’s parent network in Minot via the two-way direct trunk group.

Routing of all other landline to wireless calls involving NPA/NXX's for OCN 2577 will be in accordance to Telcordia Traffic Routing Administration instructions.

**B. Wireless-to-Landline:**

Local Service Area Calls originated by NDNC's customers under OCN 2577, and roamers on the NDNC network, to NDTC customers under Attachment 2 are routed from NDNC network via the two-way trunk group to NDTC Devils Lake Office and terminated by NDTC.

Routing of all other wireless to landline calls will be in in accordance to Telcordia Traffic Routing Administration instructions.

**2. Substitution of Amended Terms and Conditions**

Replace Attachment A, B, & C with Attachment 1 & 2.

**3. This Amendment shall be effective April 23, 2013.**

Except as expressly set forth herein, the terms and conditions of the Original Agreement shall remain in full force and effect without change.
