AMENDMENT TO INTERCONNECTION AGREEMENT

THIS AMENDMENT TO INTERCONNECTION AGREEMENT ("Amendment") this ~~2011~~ day of Oct. 2013, and effective as herein provided by and between Consolidated Telcom, ("ILEC") with offices at 507 S. Main Dickinson, ND 58601 and Midcontinent Communications ("CLEC") with offices at 3901 North Louise Avenue, Sioux Falls, SD 57107. This Amendment may refer to either CLEC or ILEC or both as a "Party" or "Parties."

WITNESSETH

WHEREAS, ILEC is a local exchange telecommunications company authorized to provide telecommunications services in the state of North Dakota; and

WHEREAS, CLEC is a competitive local exchange telecommunications company authorized to provide telecommunications services in the state of North Dakota; and

WHEREAS, the Parties have entered into an agreement (the "Agreement") pursuant to Sections 251 of the Telecommunications Act of 1996 ("the Act") for the provision of interconnection, local number portability and collocation services by ILEC to CLEC, and that agreement has been approved by the North Dakota Public Service Commission (the "Commission"); and

WHEREAS, the Parties wish to amend their Agreement and amendments thereto (the "Amendment") specifically for the purposes of fulfilling their obligations pursuant to Sections 251 of the Act.

NOW THEREFORE, in consideration of the mutual agreements contained herein, CLEC and ILEC agree as follows:

1. Substitution of Exhibit 1 to the Interconnection Agreement
