**PSC Schedules Public Hearing in Tioga for Proposed Aurora Wind Project  
and Associated Transmission Line**

BISMARCK, ND – The North Dakota Public Service Commission (PSC) will hold a public hearing in Tioga on Monday, February 25, regarding a proposal to construct a wind farm in Williams County and associated electric transmission line in Williams and Mountrail Counties.

Aurora Wind, LLC (a wholly-owned subsidiary of Tradewind Energy, Inc), has submitted applications for permits for the Aurora Wind Project and an associated transmission line. The wind farm will have a capacity of approximately 300 megawatts and will consist of up to 123 wind turbine generators and associated facilities. Associated facilities include access roads, electric collection and communication systems and cabling, an operations and maintenance building, meteorological evaluation towers, and a project substation. The project area would encompass approximately 44,000 acres located approximately five miles northwest of Tioga. Total cost of the wind project is estimated at \$385 million.

The project will also include a 20-mile long, 345-kilovolt (kV) transmission line that would run from the wind project in Williams County to Basin Electric's Tande Substation in Mountrail County. Total cost of the transmission line is estimated at \$15 million.

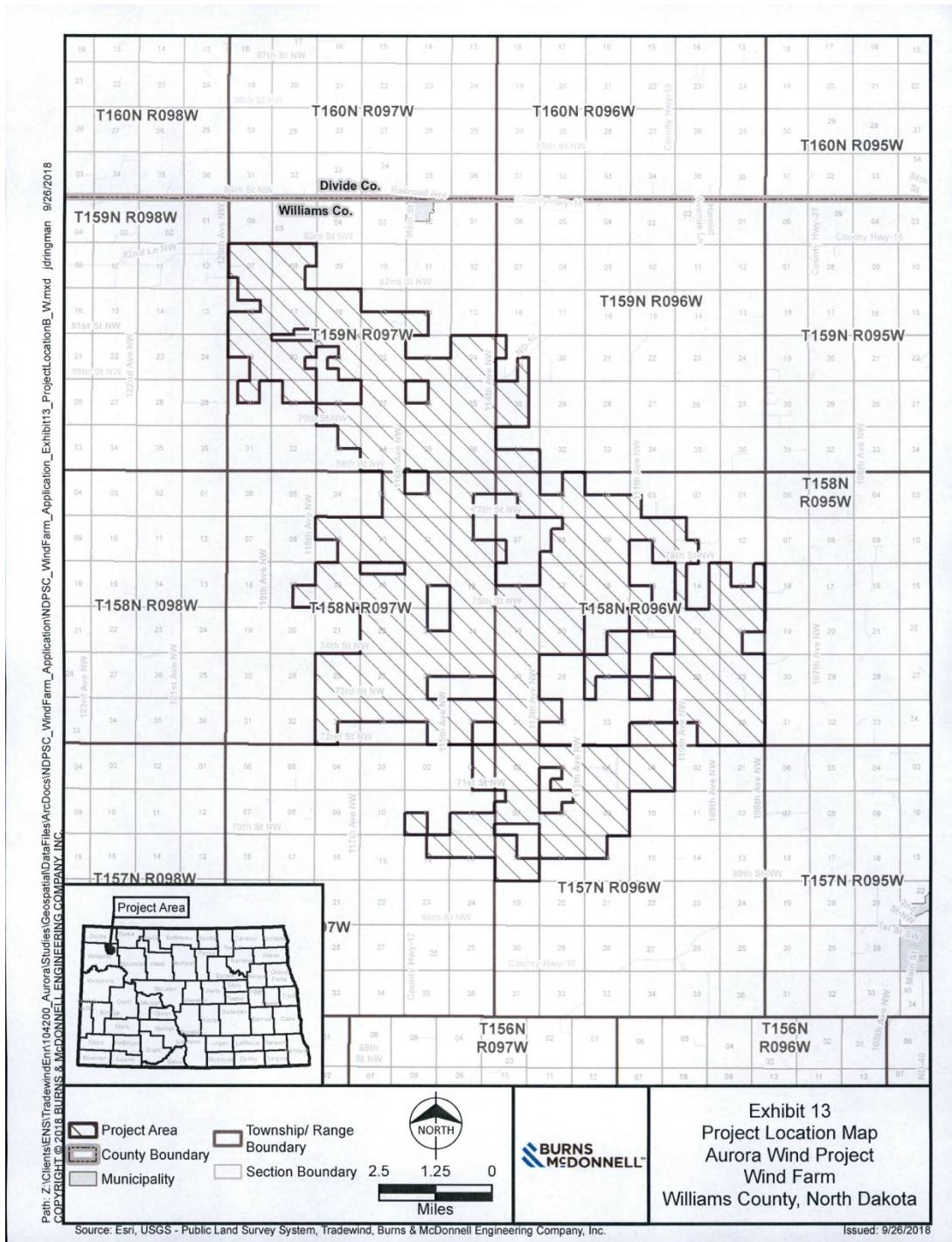

Information received after the hearing will not be part of the official record and cannot be used as a basis for the Commission's decision unless certain additional procedures are followed.

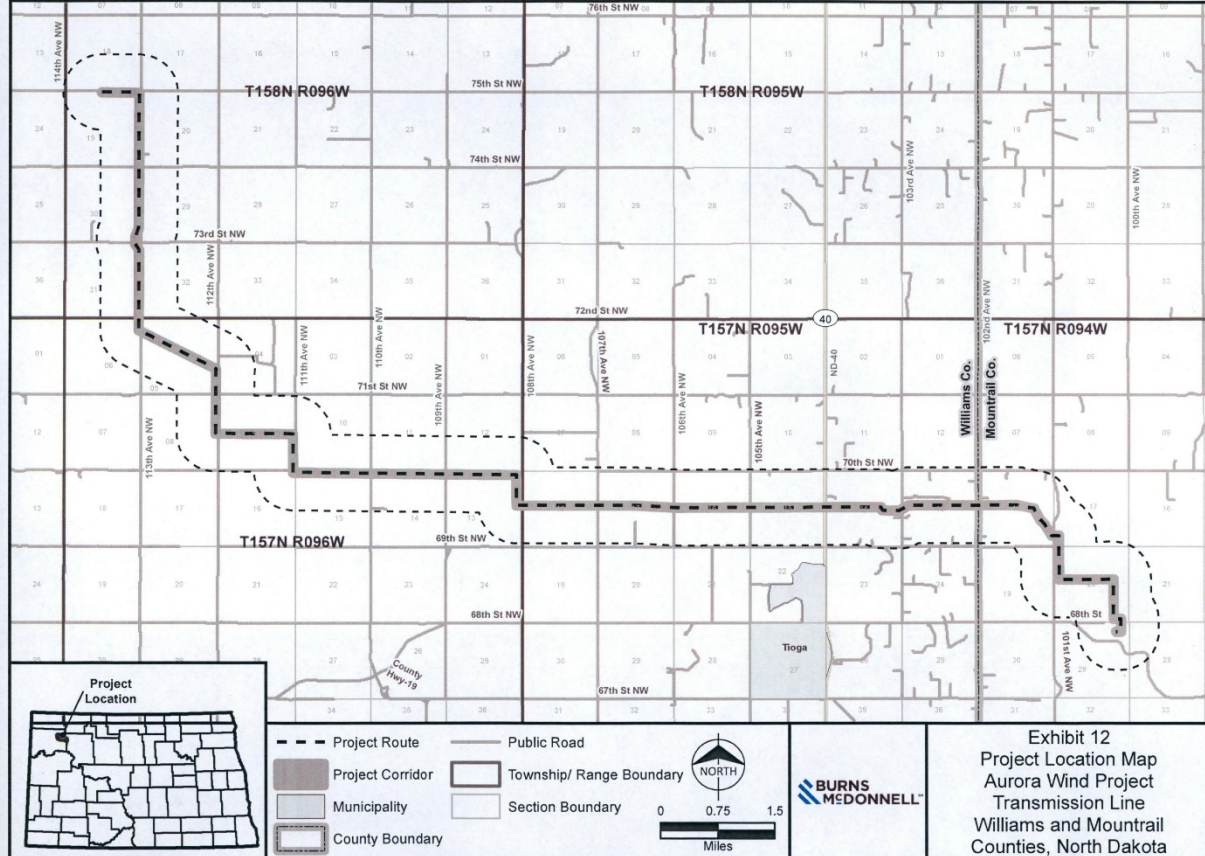
The North Dakota Public Service Commission is a constitutionally created state agency with authority to permit, site and regulate certain business activities in the state including electric and gas
