**NOTICE OF AMENDED FILING AND NOTICE OF RESCHEDULED HEARING**

**March 14, 2001**

On January 5, 2001 Great River Energy (GRE) filed a consolidated application for a waiver of procedures and time schedules, a certificate of corridor compatibility and a route permit authorizing construction and relocation of approximately 35 miles of 230 kV electric transmission line in Benson and Ramsey Counties of North Dakota.

On January 10, 2001 the Commission deemed the application complete and issued a Notice of Filing and Notice of Hearing, scheduling a public hearing for February 6, 2001. On January 12, 2001, the Commission amended the notice to change the location of the hearing. On January 24, 2001 the Commission postponed the hearing to a date to be determined.

On March 7, 2001, GRE filed an amendment to its application. The amendment revises GRE's originally proposed route and identifies an alternative route as shown on the attached map. The new proposed and alternative routes are within GRE's originally proposed corridor located within T153N, R67W, Sections 3-6, T154N, R67W, Sections 1-4, 7-34, T155N, R67W, Sections 22-27, 33-36 of Benson County and T154N, R66W, Sections 1-7, 11, 12, 18, T155N, R66W, Sections 19-36, T154N, R65W, Sections 1-18, 20-26, T155N, R65W, Sections 30-33, T153N, R64W, Sections 1-3, 10-12, T154N, R64W, Sections 7-36, T153N, R63W, Sections 5-8, T154N, R63W, Sections 7, 17-20, 29-32 of Ramsey County. Landowners within the proposed corridor should be aware that this electric transmission line could be routed across their land.

GRE states that a demonstrable emergency exists and the proposed transmission line will produce minimal adverse effects. GRE requests the Commission (1) waive provisions of law that require separate applications, separate notices and separate hearings for waivers of procedures and time schedules, certificates of corridor compatibility and route permits; and (2) issue a certificate of corridor compatibility and route permit authorizing the proposed project.

The **public hearing** on this matter originally scheduled for February 6<sup>th</sup> has been **rescheduled for April 16, 2001 at 12 Noon (CST) in the Ramsey County Courthouse, 524 4th Ave., Armory Meeting Room located at the south end of the Memorial Building, Devils Lake, North Dakota.**

The issues to be considered in this proceeding are:

1. Will the location, construction, and operation of the proposed transmission line produce minimal adverse effects on the environment and upon the welfare of the citizens of North Dakota?
2. Is the proposed transmission line compatible with the environmental preservation and the efficient use of resources?
3. Will the proposed transmission line corridor and route minimize adverse human and environmental impact while ensuring continuing system reliability and integrity and ensuring that energy needs are met and fulfilled in an orderly and timely fashion?
4. Is the proposed transmission line of such length, design, location, or purpose that it will produce minimal adverse effects so that procedures and time schedules may be waived?
5. Does a demonstrable emergency exist which requires immediate construction so that adherence to procedures and time schedules would jeopardize the utility's system?
6. Is it appropriate for the Commission to waive any procedures and time schedules as requested in the application?

Anyone wishing to be heard regarding this proceeding will be given an opportunity at the hearing. Anyone wishing to become a party to the proceeding must file a petition to intervene with the Commission under N.D. Admin. Code Section 69-02-02-05.
