


ORDER

June 5, 2002

On March 25, 2002, Qwest Corporation (Qwest) filed an application for approval of an amendment negotiated to its interconnection agreement with Midwest Wireless Communications, L.L.C. of Overland Park, Kansas, Case No. PU-2683-02-151. This amendment sets forth intercarrier compensation for Internet service provider bound traffic in accordance with the FCC order in CC Docket Nos. 96-98 and 99-68.

On March 25, 2002, Qwest Corporation (Qwest) filed an application for approval of an amendment negotiated to its interconnection agreement with Sprint Communications Company, L.P. of Overland Park, Kansas, Case No. PU-2057-02-152. This amendment sets forth rates terms and conditions for DC Power Reduction Procedure.

On April 5, 2002, applications for approval of amendments negotiated to wireless interconnection agreements with WWC Holding Co., Inc. were filed by: BEK Communications Cooperative (Case No. PU-2536-02-153); Dakota Central Telecommunications Cooperative (Case No. PU-2542-02-154); Dakota Central Telecom 1 (Case No. PU-2543-02-155); Dickey Rural Telephone Cooperative (Case No. PU-2555-02-156); Dickey Rural Communications, Inc. (Case No. PU-2556-02-157); Griggs County Telephone Company (Case No. PU-2553-02-158); Intercommunity Telephone Company, L.L.C. (Case No. PU-2551-02-159); Intercommunity Telephone Company II, L.L.C. (Case No. PU-2552-02-160); Midstate Telephone Company (Case No. PU-2540-02-161); Midstate Communications Inc. (Case No. PU-2539-02-162); Moore and Liberty Telephone Company (Case No. PU-2554-02-163); North Dakota Telephone Company (Case No. PU-2684-02-164); Northwest Communications Cooperative (Case No. PU-2544-02-165); Polar Communications Mutual Aid Corporation (Case No. PU-2685-02-166); Polar Telecommunications, Inc. (Case No. PU-2686-02-167); Red River Rural Telephone Association (Case No. PU-2549-01-168); Red River Telecom, Inc. (Case No. PU-2548-02-169); Reservation Telephone Cooperative (Case No. PU-2528-02-170); Turtle Mountain Communications, Inc. (Case No. PU-2537-02-171); United Telephone Mutual Aid Corporation (Case No. PU-2538-02-172); and West River Telecommunications Cooperative (Case No. PU-2579-02-173). These amendments revise the reciprocal compensation rates contained in the original agreements.

On April 17, 2002, Qwest filed an application for approval of an amendment negotiated to its interconnection agreement with U.S. Link, Inc., of Pequot Lakes, MN, Case No. PU-2630-02-195. This amendment adds rates, terms and conditions to the original agreement for Qwest DSL provided with UNE-P combinations.

These agreements were filed under Section 252(e) of the Telecommunications Act of 1996 (Act). The Act requires that any agreement adopted by negotiation or arbitration be submitted for approval to the Commission. Under section 252(e)(2)(A), the Commission may only reject an agreement (or portion thereof) adopted by negotiation if it finds that:

1. the agreement (or portion thereof) discriminates against a telecommunications carrier that was not a party to the agreement;
2. the implementation of the agreement (or portion thereof) is not consistent with the public interest, convenience, and necessity.

In addition, the Commission may include in its review state requirements that do not constitute barriers to entry under section 253.

On April 24, 2002, the Commission issued a Notice of Opportunity to File Written Comments, which provided that the Commission would receive comments on the agreements until May 28, 2002. No comments have been received.




Order

The Act requires that any agreement adopted by negotiation or arbitration be submitted for approval to the Commission. Under section 252(e)(2)(A), the Commission may only reject an agreement (or portion thereof) adopted by negotiation if it finds that:


1. the agreement (or portion thereof) discriminates against a telecommunications carrier that was not a party to the agreement;
2. the implementation of the agreement (or portion thereof) is not consistent with the public interest, convenience, and necessity.


In addition, the Commission may include in its review state requirements that do not constitute barriers to entry under section 253. Section 252(e)(4) requires that the Commission must act to approve or reject an agreement adopted by negotiation within ninety (90) days after submission by the parties.

The Commission will receive written comments on these agreements until May 28, 2002.


