





On September 4, 2003, Qwest filed for approval of an interconnection agreement negotiated with DIECA Communications, Inc. d/b/a Covad Communications Company of Santa Clara, CA, Case No. PU-2921-03-512. This agreement sets for rates, terms and conditions for interconnection of facilities and exchange of traffic.

On September 16, 2003, Qwest filed for approval of an amendment negotiated to its interconnection agreement with Sprint Communications Company L.P. of Overland Park, KS, Case No. PU-2271-03-529. This amendment adds rates, terms and conditions for UNE-P line splitting to the original agreement.

Also on September 16, 2003, Qwest filed for approval of an interconnection agreement negotiated with Onvoy, Inc. of Plymouth, MN, Case No. PU-2928-03-530. This agreement adopts a previously approved agreement between Qwest and AT&T Corporation of the Midwest.

On September 18, 2003, Consolidated Communications Networks, Inc. filed an interconnection agreement negotiated with Cellco Partnership d/b/a Verizon Wireless of Bedminster, NJ, Case No. PU-2930-03-538. This agreement sets forth rates, terms and conditions for interconnection of facilities and exchange of traffic.

These agreements were filed under Section 252(e) of the Telecommunications Act of 1996 (Act). The Act requires that any agreement adopted by negotiation or arbitration be submitted for approval to the Commission. Under section 252(e)(2)(A), the Commission may only reject an agreement (or portion thereof) adopted by negotiation if it finds that:

1. the agreement (or portion thereof) discriminates against a telecommunications carrier that was not a party to the agreement;
2. the implementation of the agreement (or portion thereof) is not consistent with the public interest, convenience, and necessity.

In addition, the Commission may include in its review state requirements that do not constitute barriers to entry under section 253.

On September 24, 2003, the Commission issued a Notice of Opportunity to File Written Comments, which provided that the Commission would receive comments on the agreements until October 29, 2003. No comments have been received.

The Commission has reviewed the agreements and does not find them discriminatory against a telecommunications carrier that was not a party to the agreements. The Commission finds that implementation of the agreements is not inconsistent with the public interest, convenience and necessity.


