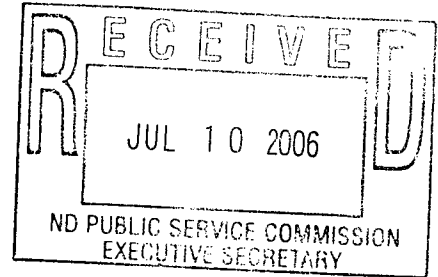

MOTION FOR THE ADMISSION PRO HAC VICE OF GLENN S. RICHARDS
