**REPLY OF NORTH DAKOTA TELEPHONE COMPANY
TO MOTION FOR LEAVE TO FILE SUPPLEMENTAL MEMORANDUM**

This Commission's rule, N.D. Admin. Code § 69-02-06-02(4), governs the time frame for filing a response to a Request for Reconsideration. This rule was clearly understood by Midcontinent Communications (herein Midco) because Midco asked the Public Service Commission (herein Commission) for an interpretation of this rule before filing its response to the Petition for Reconsideration of North Dakota Telephone Company (herein NDTC) (see attached email). Despite this, Midco now asks the Commission to ignore its own rules and to allow Midco to file a late response. NDTC resists this request.

In addition, Midco ignores that it failed to timely file its own Request for Reconsideration and now suggests that the Commission should take a different tact in this matter different than that set forth by the Commission in its Order of April 26, 2006.

NDTC resists these efforts and, to demonstrate the impropriety of Midco's request, attached hereto is a legal memorandum showing that, even if the Commission

granted Midco's request for late filing, the action urged by Midco would be ill-advised and unsupported by North Dakota law.



The rule regarding filing of a response to a petition for reconsideration is N.D. Admin. Code §69-02-06-02(4) and provides that a party may file a response within 10 days after service of the petition. The Rules of Civil Procedure are used for computation of time in administrative proceedings. N.D.R.Civ.P 6(a) provides that when the period of time prescribed is less than 11 days, intermediate Saturdays, Sundays and legal holidays must be excluded from the computation. Applying those rules, I come up with the date of May 24th as the deadline for filing of Midcontinent's response.
