AMENDED PREHEARING ORDER


Ordered, that not later than July 5, 2006, Midcontinent Communications and North Dakota Telephone Company shall each serve upon the other and prefile with the Commission the anticipated direct testimony of each of the witnesses expected to testify on their behalf for the further hearing of July 10, 2006; provided, however, that either party may offer additional direct testimony and exhibits at the time of the further hearing; and it is further

Ordered, that not later than July 5, 2006, North Dakota Telephone Company shall serve upon Midcontinent Communications and prefile with the Commission a complete copy of its cost study prepared in support of the testimony and exhibits which will be offered on its behalf for the further hearing of July 10, 2006, together with a complete copy of any compilation of data relied upon for the preparation of the cost study; and it is further

Ordered, that North Dakota Telephone Company shall open and close for the further hearing on July 10, 2006, and may offer rebuttal testimony in response to the direct testimony prefiled by Midcontinent Communications.


