Mr. Breen:

I compared the testimony you seek to protect to the trade secret information contained in the MDU and OTP trade secret information. The MDU and OTP trade secret information is essentially cost numbers and projections for various items of costs or categories of cost. The information for which you ask trade secret protection is primarily narrative testimony. You provide no justification in your request for granting trade secret protection for that information. If it is cost numbers that you seek to protect, and those cost numbers are included in the OTP and MDU information that has been protected, you need to identify those numbers. The public testimony should only redact the numbers and not broad narrative testimony.
