

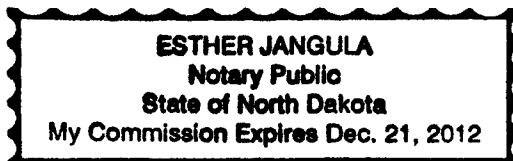

NOTICE OF CANCELLATION OF FORMAL HEARING


January 13, 2010


