

The proposed facility will consist of up to 368 MWs of wind turbine generating capacity, collection substation and associated facilities in Logan County, North Dakota.

The previously approved site continues to meet all of the conditions upon which the certificate of site compatibility was issued. There have been no changes made to the site since the initial certificate was issued in accordance with the Findings of Fact, Conclusions of Law and Order of the Commission in Case No. PU-7-54, and all study results and supporting data submitted with the initial application remain valid and unmodified.

The approximate date for the commencement of construction is July 1, 2016.

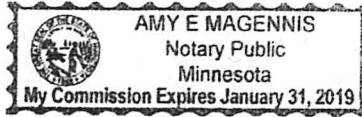


