NOTICE OF FILING AND NOTICE OF HEARING

August 22, 2007

On April 16, 2007 Enbridge Pipelines (Southern Lights) L.L.C. (Enbridge SL) filed an application for waiver of procedures and time schedules, and consolidated applications for a certificate of corridor compatibility and a route permit authorizing construction of approximately 28 miles of 20-inch liquid petroleum pipeline and associated facilities in Pembina County of North Dakota (LSr Project).

On July 16, 2007 Enbridge Energy, Limited Partnership (Enbridge LP) filed an application for waiver of procedures and time schedules, and consolidated applications for a certificate of corridor compatibility and a route permit authorizing construction of approximately 28 miles of 36-inch liquid petroleum pipeline and associated facilities in Pembina County of North Dakota (Alberta Clipper Project).

The proposed route for the pipelines is shown on the attached map.

Enbridge SL and Enbridge LP request the Commission waive the procedures set forth in North Dakota Century Code Sections 49-22-08 and 49-22-08.1 to allow for single consolidated applications for Corridor Certificate and Route Permit for their projects. Enbridge SL and Enbridge LP further request that the Commission reduce the minimum width of the corridor for their projects, from 2.8 miles, required under North Dakota Administrative Code Section 69-06-04-02, to 1 mile.

The Commission finds the application of Enbridge SL is complete. The Commission finds the application of Enbridge LP is complete.

A public hearing on these applications is scheduled to begin **Tuesday, October 2, 2007 at 1:30 p.m. at the Cavalier Law Enforcement Center, Lower Level Meeting Room, Courthouse Drive, Cavalier, North Dakota.**


