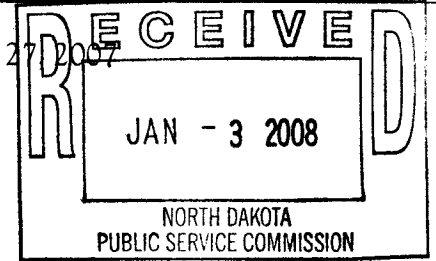

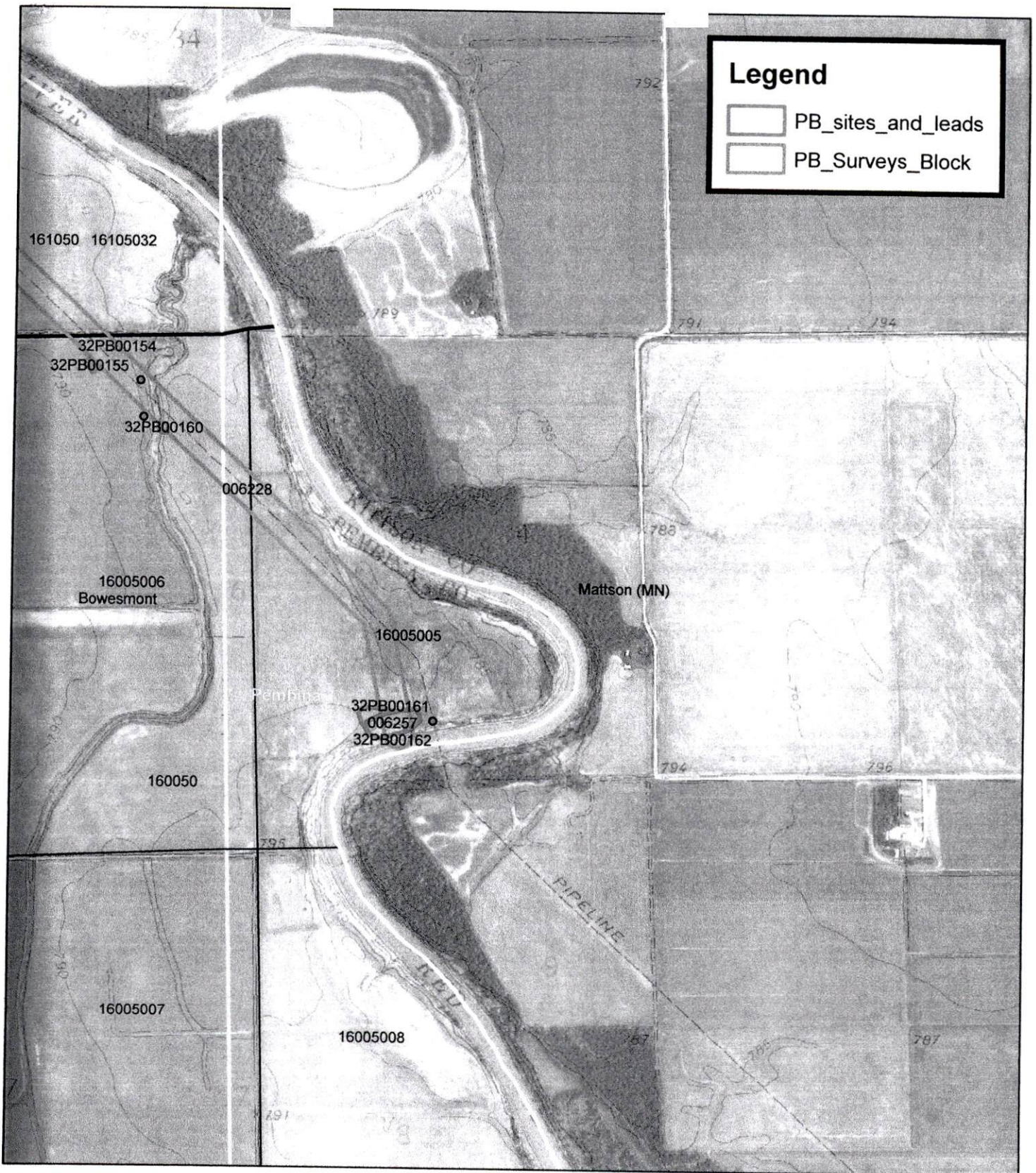

We would concur with "No Significant Sites Affected" and "No Historic Properties Affected" determinations, if consulted by federal and state agencies, provided the project is of the nature stated and it takes place in the described location.
