In compliance with the North Dakota Public Service Commission's December 31, 2007 Ordering Paragraph 20 in Docket No. PU07-108, Enbridge Energy, Limited Partnership (Enbridge) hereby submits for filing an original and 10 copies the following information on the new private access road required during construction of its 36-inch Alberta Clipper pipeline in Pembina County, North Dakota.

Enbridge will need only one new private access road for its Alberta Clipper Project, as approved in the above referenced docket number. The new temporary access road will be located totally within Tract No. 1120 in Neche Township, Pembina County. The temporary road will extend directly north from 109<sup>th</sup> Street Northeast where it will join the Enbridge right-of-way at Mile Post 773.9 on the Alberta Clipper pipeline. See map enclosed herewith as Attachment A.

All other ingress and egress to the right-of-way are by way of public roads where no special permissions and/or improvements are needed. These roads are not designated as "access roads" because there are no restrictions on their use (except perhaps for seasonal weight restrictions, which Enbridge will observe).

Enbridge is also enclosing a CD which contains the same information that is being filed herein.

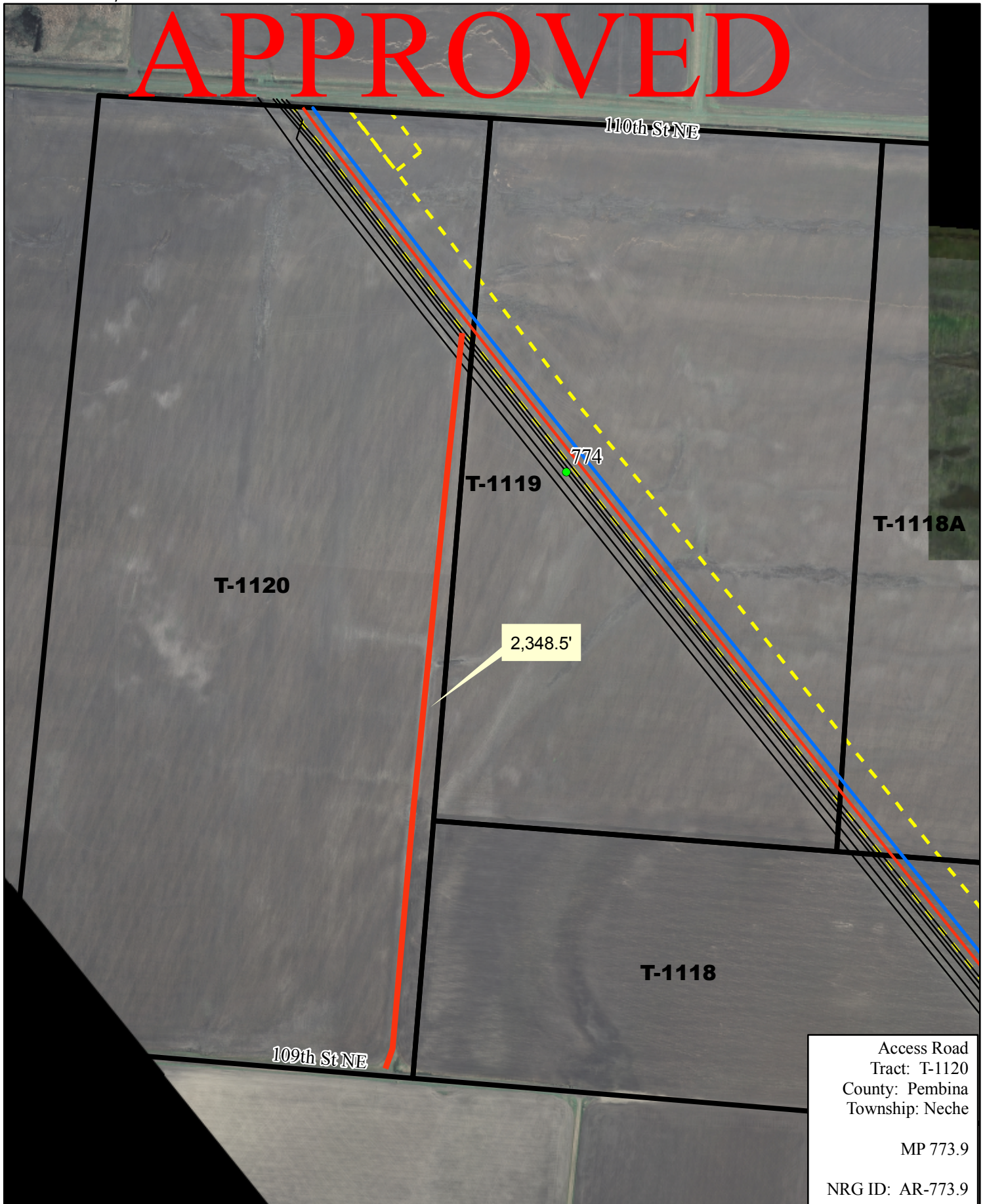

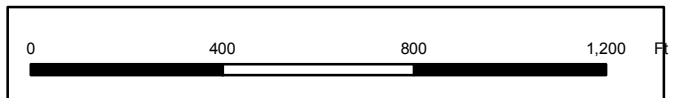
