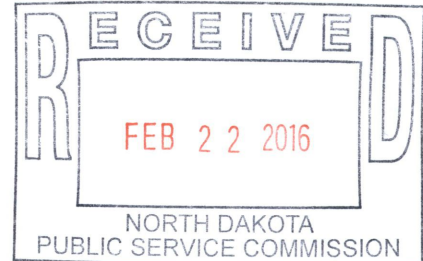

Enbridge Energy, Limited Partnership provides the enclosed information in response to the request from Mr. Patrick Fahn dated February 2, 2016. Mr. Fahn requested the following information regarding Docket PU-07-108:

Case No. PU-07-108

On December 31, 2007, the North Dakota Public Service Commission issued an order in this case authorizing the Company to construct 28 miles of 36-inch liquid petroleum pipeline adjacent and parallel to its existing pipelines in Pembina County, North Dakota (Alberta Clipper Pipeline).

As per the post construction inspection report, the following information should be provided:

- Monitoring of open cut roads which had settled and formed slight depressions. (See Appendix A, Photos 11, 27, 30, 34 and 36 in the post construction report)

Enbridge hereby requests additional time to provide a response to the request from Mr. Fahn. Presently, the areas identified in the photographs listed above are covered with snow and the ground is frozen. The Enbridge Superior Region, which oversees the Alberta Clipper Pipeline, has indicated that as soon as the snow melts and the ground thaws, it will inspect these areas and provide a report to the ND PSC.

If conditions prevent the Superior Region from providing a report by May 13, 2016, Enbridge will again request additional time to provide a response.

Please report whether any repairs have been made regarding these locations of roadbed settling and, if so, whether Enbridge believes the issue at each location has been resolved.
