STIPULATION FOR DISMISSAL

COMES NOW the Complainant, Capital Electric Cooperative, Inc., by and through their attorney, Carol K. Larson of Pringle & Herigstad, P.C., 2525 Elk Drive, PO Box 1000, Minot, North Dakota, 58802-1000, and the Respondent, Montana-Dakota Utilities Inc., a Division of MDU Resources Group, Inc., by and through their attorney, Daniel S. Kuntz, Associate General Counsel, MDU Resources Group, Inc., PO Box 5650, Bismarck, ND 58502-5650, and stipulates that the Plaintiff's Complaints stated above be in all things dismissed, with prejudice, and without cost to either party. The Complaints have been settled as part of a comprehensive service area agreement which establishes services areas and designates services locations to be served by Montana-Dakota and Capital Electric within the city of Bismarck, North Dakota, and the surrounding area. By order of the Public Service Commission (PSC) dated January 16, 2008, the area service agreement was approved and Capital Electric was designated to serve the service locations identified in the Complaints within Promontory Point III,

Sonnet Heights, and Promontory Point IV.
