

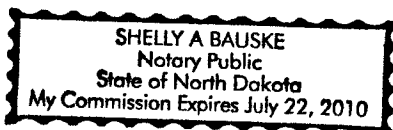



**NOTICE OF CANCELLATION OF FORMAL HEARING AND
