Dear Mr. Larson:

The North Dakota Public Service Commission retained Wenck Associates, Inc. (Wenck) to complete a post construction inspection under the authority provided for in the above referenced case. Below we provide a weblink to their post construction inspection report for your review and a link to the Commission's order in this proceeding. We also list actions recommended in the post construction inspection report for follow-up by the Company to confirm compliance with the Commission order.

As per the post construction inspection report, the following actions should be undertaken with information documenting these actions provided to the Commission:

- Installation of erosion control structures at the Pillsbury Substation entrance and monitoring until stabilized. (Order Points 13,14, and 16)
- Provision of the final hardcopy, electronic copy, and GIS file as-built drawings. (Order Point 20)
- Written explanation of how bird deterrent placement was determined along the route, specifically in relation to high avian use areas and proximity to wetlands. (Order Points 8 and 9)
- Compliance with National Electric Safety Code. (Order Point 8)
- Waivers from all residents within 500 feet. (Order Point 6)
- Permits/Approvals from other agencies. (Order Point 6)
- Construction according to Application and safety requirements (Order Point 8)
- Reports of presence of threatened, endangered species or bald or golden eagles, if applicable (Order Point 8)
- Reports of cultural, archeological, historical resources found, if applicable (Order Point 9)
- Mitigation of television and radio interference (Order Point 17)

- Aeronautics Commission request: search of private airports, FAA consultation completed under Form 7460 (receipt of study results needed). (Order Points 6 and 8)
- Compensation for landowners for crops and impacts to CRP status. (Order Points 6 and 8)
