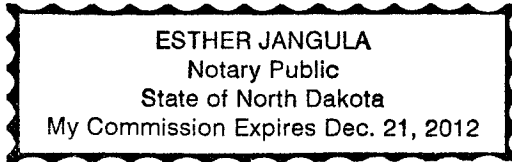

NOTICE OF OPPORTUNITY FOR HEARING

On May 12, 2008, Otter Tail Corporation, an electric public utility, filed an application under Chapter 49-03, N.D.C.C. to extend service to Luke Spitzer, near Kensal, in Stutsman County, North Dakota.
