The North Dakota Public Service Commission recently received a letter updating the contact information for your companies. This change may require that you provide or update information found in your electronic registration at the Commission's website:



Please note: **Every telecommunications company that is not an incumbent local exchange company MUST REGISTER USING this electronic process.** This includes companies that already had certificates of public convenience and necessity or registration certificates. Under NDCC § 49-03 .1-09, effective 01 August 2005, **certificates of public convenience and necessity for facilities-based providers and registration certificates for resellers ARE NO LONGER EVIDENCE OF AUTHORIZATION to provide service in North Dakota . AUTHORITY TO PROVIDE SERVICE is now a consequence of registration via the new web-based program.**

Every registered company must keep its electronic registration information updated, including withdrawal of the electronic registration when the company is no longer providing service in North Dakota.
