

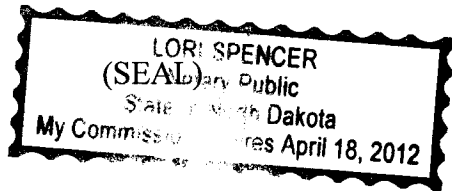



On June 25, 2008, the City of Fargo filed a Request for Hearing and a Petition to Intervene as a Party in the above matter.


