**NOTICE OF OPPORTUNITY FOR HEARING**

**May 21, 2008**

On May 2, 2008, Otter Tail Corporation filed an application for a Certificate of Public Convenience and Necessity to construct and own a 48 MW portion of the approximately 200 MW Ashtabula Wind Energy Center and associated 34.5 kV collector lines and electrical facilities proposed in Barnes County, North Dakota.

The issues to be considered in this matter are:


1. Whether public convenience and necessity will be served by construction and ownership of the facilities.
2. Whether the applicant is fit, willing and able to provide service.

Those interested are invited to comment on this application in writing. Persons desiring a hearing must file a written request identifying their interest in the proceeding and the reasons for requesting a hearing. Comments and requests for hearing must be received by **June 23, 2008**. If deemed appropriate, the Commission can determine the matter without a hearing.
