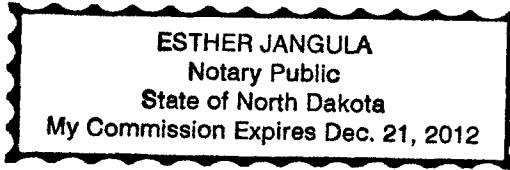

Submitted with the application was a statement from the customer, Craig Reamann, that he desires electric service to be provided by the applicant at a point located in:


**SW ¼, NE ¼, Section 31, Township 133, Range 47, a/k/a
