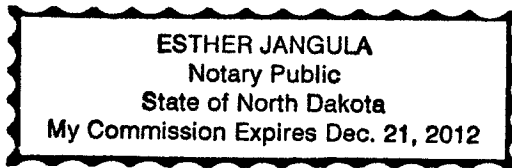

County, North Dakota**


Otter Tail Corporation states that electric service is needed at this location immediately, and the applicant has made a prima facie showing that it should serve the customer.
