
All rates in this tariff have been increased. THPP is filing this tariff to ensure that the rates are consistent with the rates filed with the Federal Energy Regulatory Commission.

NOTE 1

- a. When gathering is performed into Battleview, Black Slough, Blue Butte, Charlson, Dodge, Keene, Lignite, Tioga and Ytredahl, the through rate to destination will be made by adding [I] 52.89 cents per barrel to the rate named in this column.
- b. When gathering service is performed into Alexander Station, Cartwright Station and Whitetail Station, the through rate to destination will be made by adding [I] 47.71 cents per barrel to the rate named in this column.

NOTE 2

There will be an additional [I] 13.61 cents per barrel charged when trucks are unloaded at any THPP main line origin facility in North Dakota.
