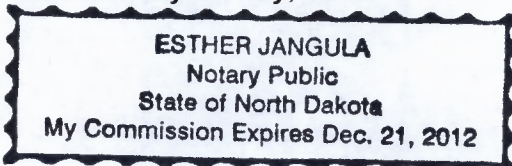

TO DISCONTINUE BUSINESS**




