FROM: Three Hundred Forty Five Thousand Dollars and 00/100 (\$345,000.00)


TO: Four Hundred Forty Thousand Dollars and 00/100 (\$440,000.00)

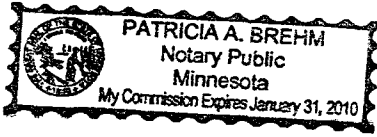
