4.4 Rate Promotions

4.4.1 PRIme TIme Promotion

**Eligibility:** The PRIme TIme Promotion is available for new and existing retail customers signing a term agreement of at least twenty-four (24) months for Preferred Advantage Dedicated Local T1 or PRI services. Existing retail Preferred Advantage Dedicated Local T1 or PRI customers who are currently under term agreement will be required to extend their term a minimum of two years in order to qualify for the promotional pricing. Promotional pricing may be used in conjunction with standard McLeodUSA Term and Volume Discounts.

The promotional period shall begin with the effective date of this tariff and end on **September 30, 2008.**

**Promotion:** This promotion reduces the monthly recurring price for eligible customers subscribing to McLeodUSA Preferred Advantage Dedicated Local T1 or PRI services. The promotional pricing applies to 12, 16, 20 or 24 channel T1 or PRI configurations. The PRIme TIme Promotion is available in select Central Offices, depending on network capacity. When capacities are exhausted in a Central Office, the promotion will no longer be available in the impacted Central Office. The standard Preferred Advantage monthly and nonrecurring pricing will apply for all optional features, feature changes and order activity.
