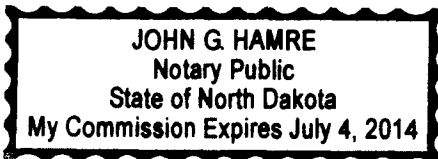


On July 11, 2008, the Commission was notified that the auction clerk bond issued to Joe Lissolo would be canceled on September 15, 2008.
