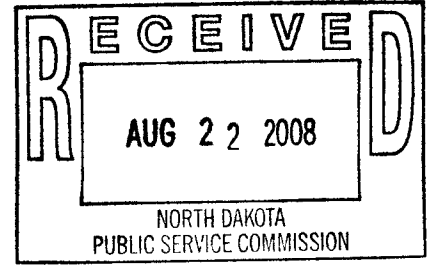



## POWER OF ATTORNEY

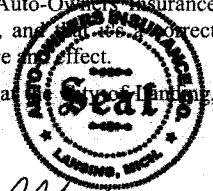
