Dear Mr. West:

On October 1, 2008, our office received a Name Change Rider for your North Dakota Roving Grain Buyer Bond No. 100181966 08-14. This rider reflects a name change from ADM Malting LLC to Malteurop North America Inc. and is effective August 1, 2008. According to the North Dakota Secretary of State records, ADM Malting, LLC has been "retired by merger" and Malteurop North America Inc. registered as a foreign business corporation effective August 15, 2008. I am returning this Name Change Rider to you.

Licenses do not transfer from one entity to another. Therefore we will need a written request from you to discontinue operating ADM Malting, LLC as a roving grain buyer and Malteurop North America Inc. must apply for a roving grain buyer license.

The roving grain buyer license application forms are available electronically via the Commission's website at www.psc.state.nd.us under the Grain and Hay Jurisdiction. Please file a completed roving grain buyer license application and bond in an amount sufficient to cover your anticipated grain purchases.

On October 1, 2008, we also received a Name Change Rider for Bond No. 100181966 08-08. According to our records, we do not have this bond on file for ADM Malting, LLC. I am returning this Name Change Rider to you.
