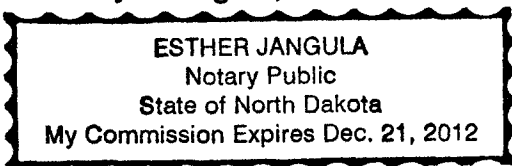

ORDER GRANTING LICENSE APPLICATION




