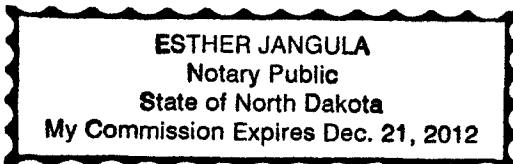

TO DISCONTINUE BUSINESS




Quarter Circle Y, Co. dba Hepper Feed operates a licensed public grain warehouse at Selfridge, North Dakota, under license number 1119 issued by the Public Service Commission under the provisions of NDCC Chapter 60-02. A license renewal application was not received for this facility. Therefore, as provided in ND Admin. Code § 69-07-02-03, the failure to file an application in a timely manner will result in the automatic discontinuance of business for the Selfridge facility.

Order

The Commission orders that Quarter Circle Y, Co. dba Hepper Feed's public grain warehouse license is automatically discontinued effective August 1, 2008, for failure to file an application in a timely manner. Quarter Circle Y, Co. dba Hepper Feed shall remit license number 1119 to the Commission.
