At the request of the appellant, the Commission is certifying additional documents for the record on appeal. These documents are an undocketed electronic copy of docket entry number 16, *Response to October 14th Deficiency Letter*, and permit revisions that were not docketed but were filed on 28 January 2010, at the same time as docket entry number 16.

Because the permit revisions were filed with the Public Service Commission only electronically, on disc, it is impractical to include an electronic copy of docket item #16 on the same disc as the permit revisions. Rather than include a paper copy with an otherwise totally electronic record, and because an undocketed copy of the same letter is already included with the permit revisions, no additional copy of docket item #16 is included in the Certification Supplement.


