

I. INTRODUCTION

WWC Holding Co. Inc. d/b/a Alltel Communications, LLC¹ (the “Company” or Alltel”), submits this Annual Report in compliance with the North Dakota Public Utilities Commission (“Commission”) Orders designating Alltel as an Eligible Telecommunications Carrier (“ETC”) and the Commission’s rules regarding the annual ETC certification and reporting process – NDAC §§ 69-09-05-12 et seq. Alltel respectfully requests the Commission to certify its eligibility for high-cost support from the federal universal service fund for calendar year 2009.

II. BACKGROUND

The Commission has designated Alltel as a competitive ETC in certain non-rural wire centers served by Qwest Corporation,² and the full study areas of several rural telephone companies.³ As an ETC, Alltel is required to and, therefore, provides the nine supported services, including:

- Voice grade access to the Public Switched Telephone Network;
- Local Usage;
- Dual tone multi-frequency signaling or its functional equivalent;
- Single party service or its functional equivalent;
- Access to 911 or E911;
- Access to operator services;
- Access to interexchange services;
- Access to directory assistance; and
- Toll limitation for qualifying low-income customers.

A complete listing of the areas in which Alltel has been designated as an ETC, and is requesting federal universal service support, is contained in **Exhibit A** (“Designated Areas”).

III. ALLTEL’S ANNUAL REPORT

NDAC § 69-09-05-12.1 requires a common carrier previously designated by the Commission as an ETC to annually report certain additional information no later than August 1 of each calendar year (beginning in calendar year 2007). Alltel respectfully submits the following information in satisfaction of the Commission’s annual reporting requirement.

A. Progress Report on its Service Improvement Plan

NDAC § 69-09-05-12.1(1) requires an ETC to file a progress report on its Service Improvement Plan. Attached as **Confidential Exhibit B-1** is the comprehensive progress report identifying Alltel’s investments and expenditures on a wire-center by wire center basis for calendar year 2007. In addition to identifying the actual investments and expenditures incurred, the progress report also identifies the actual amount of universal service support received by Alltel during calendar year 2007.

Further, in accordance with the above rule, Alltel has also developed an updated two-year plan that describes with specificity the proposed improvements or upgrades to its network serving its North Dakota Designated Areas. Alltel’s proposed Two-Year Service Improvement Plan is attached as **Confidential Exhibit B-2** (“Service Improvement Plan”). The Service Improvement Plan includes all information required by NDAC § 69-09-05-12.1(1) for calendar years 2008 through 2009. The projected expenditures in the Service Improvement Plan are based on the assumption that Alltel will receive the same amount of federal high-cost universal service support during the calendar year 2008 and beyond that the company received in 2007. Beyond 2008, it is difficult, if not impossible, for Alltel to predict with any amount of certainty, how much the Company may receive in federal universal service support. There are various

factors that affect the total amount of support Alltel can be expected to receive, including, but not limited to, the per line support that is available, federal policy changes, Universal Service Administrative Company (“USAC”) reconciliations, and other factors beyond Alltel’s control. If actual receipts are affected, Alltel reserves the right to modify its capital and operating expenditures in the Company’s ETC service area.

B. Network Outages In North Dakota Designated Areas

NDAC § 69-09-05-12.1(2) requires an ETC to annually report network outages within its Designated Area. NDAC § 69-09-05-12.1(2) specifically requires:

detailed information on any outage, as that term is defined in 47 C.F.R. § 4.5, of at least 30 minutes in duration for each service area in which an eligible telecommunications carrier is designated for any facilities it owns, operates, leases, or otherwise utilizes that potentially affect (a) at least ten percent of the end users served in a designated service area; or (b) a 911 special facility, as defined in 47 C.F.R. § 4.5(e). Specifically, the eligible telecommunications carrier’s annual report must include information detailing: (a) the date and time of onset of the outage; (b) a brief description of the outage and its resolution; (c) the particular services affected; (d) the geographic areas affected by the outage; (e) steps taken to prevent a similar situation in the future; and (f) the number of customers affected.

This information, for the time period January 1, 2007 through December 31, 2007,⁴ is contained within **Confidential Exhibit C**. Alltel has compiled and reported information for all outages, as defined in NDAC § 69-09-05-12.1(2) in its North Dakota Designated Area – Study Area Code 389001. The information includes any outage that may potentially affect at least ten percent (10%) of Alltel’s customers in the Designated Areas or an outage of a 911 facility. The information relating to the number of customers affected by an outage is estimated based on the

number of customers with a billing address in each affected wire center as of December 31, 2007.

Each network outage is examined on a case by case basis. The outage is analyzed for the particular cause of the outage. When the outage is due, for example, to equipment failure, the equipment is replaced or repaired and tested for proper performance. Additionally, the manufacturer or vendor is notified if the failure appears to be in the design or manufacture of the equipment. If the vendor or manufacturer fails or refuses to remedy the deficiency then a replacement source is determined. When the outage is due to, for example, weather or other natural occurrence, the probability of a repeat occurrence is considered and evaluated and is considered in planning the repair, replacement or rebuild of the equipment or location. Outages due to human error or a faulty process or practice will result in appropriate reevaluation of the source of error and the need to either correct, discipline or revise the person or practice, as applicable. The outages reported above were not determined to require extraordinary measures other than application of the above.

C. Unfulfilled Requests For Service

NDAC § 69-09-05-12.1(3), requires an ETC to annually report the number of requests for service from potential customers within the ETC's designated service areas that were unfulfilled during the past year. The filing must also detail how the ETC attempted to provide service to those potential customers. The required information concerning Alltel's unfulfilled requests for service within its Designated Areas from January 1, 2007 through December 31, 2007 is contained in **Confidential Exhibit D**.

D. Complaints Per 1,000 Handsets Or Lines

NDAC § 69-09-05-12.1(4), requires an ETC to make an annual report of the number of complaints per 1,000 handsets or lines. The number of written complaints per 1,000 handsets,

throughout the state of North Dakota, that Alltel received from its customers, the Commission, the Federal Communications Commission (“FCC”), the North Dakota Attorney General, Better Business Bureau or similar third party consumer agency between January 1, 2007 and December 31, 2007 is 0.6291%. The percentage of complaints is calculated based on the number of subscribers served by Alltel throughout the state of North Dakota as of December 31, 2007.

E. Certification Regarding Applicable Service Quality Standards And Consumer Protection Rules

NDAC § 69-09-05-12.1(5) requires an ETC to certify that it is complying with applicable service quality standards and consumer protection rules. The FCC found that a wireless carrier’s compliance with the CTIA Consumer Code for Wireless (“CTIA Code”) satisfies this requirement. During 2007, Alltel was a compliant signatory to the CTIA Code. Therefore, Alltel certifies that it is complying with applicable service quality standards and consumer protection rules.

F. Certification Regarding Its Provision Of A Comparable Local Usage Plan

Alltel certifies that it is offering a local usage plan comparable to the incumbent LEC, in the relevant service areas, as required by NDAC § 69-09-05-12.1(7).

G. Certification Regarding The FCC’s Ability To Provide Equal Access

Alltel certifies that the FCC may require it to provide equal access to long distance carriers within its Designated Area in the event that no other ETC is providing equal access as described in NDAC § 69-09-05-12.1(8).

H. Certification Regarding Emergency Functionality

NDAC § 69-09-05-12.1(6) requires an ETC to certify that it is able to function in emergency situations. Alltel provides the following information to certify and demonstrate its ability to remain functional in emergency situations. Alltel’s network is designed to be able to


remain functional in emergency situations. Alltel has reasonable amounts of back-up power to provide functionality without an external power source, and, in many areas, has the ability to reroute traffic around damaged facilities and manage traffic spikes resulting from emergency situations. Alltel has deployed fixed and portable back-up power generators at various locations throughout its network that can be deployed in emergency situations. These back-up power generators are capable of keeping a cell site up and running until power is restored to the cell site, a portable generator is moved to the site, system changes are made to reroute traffic or a cell on wheels (“COW”) is deployed. Alltel tests its back-up power generators regularly to ensure functionality. Alltel is also capable of rerouting traffic around damaged or out-of-service facilities by changing call routing translations as needed. Alltel is generally able to deploy COWs as temporary cell sites when existing facilities are damaged or out-of-service for longer periods of time. Further, by changing call routing translations or deploying COWs, Alltel is generally able to manage traffic spikes throughout its network. As a long-term solution for managing increased traffic levels and traffic spikes, Alltel may increase capacity at its cell sites, switches and transport facilities. Alltel certifies that it is able to function in emergency situations.

IV. CONCLUSION

Based on the foregoing information, Alltel Communications, LLC respectfully requests that by October 1, 2008, the Commission to certify to the FCC and Universal Service Administrative Company (“USAC”) its eligibility to receive federal universal service support for calendar year 2008 in accordance with 47 C.F.R. §§ 54.313 and 54.314.




