Re: September 2008 Fuel Clause Adjustment

Dear Ms. Geiger:

Northern States Power Company, a Minnesota corporation operating in North Dakota hereby submits electric fuel clause adjustment (FCA) for September 2008.

The average cost of fuel reflected in this adjustment was 2.994¢ per kWh, which was 0.059¢ higher than last month.

Combined with the recovery provision adjustment, the net adjustment to base fuel rates is 2.222¢ per kWh. The estimated FCA impact to the monthly electric bill of a residential customer using 750 kWh is approximately \$16.67, or \$2.65 more than previous month.


MISO DAY 2 IMPLEMENTATION

This filing includes our reporting of the Midwest Independent System Operator ("MISO") charges under the Day 2 Market. Pursuant to the Commission's Order (Docket No. PU-05-147) dated April 6, 2005, Xcel Energy is authorized to recover on an interim basis, subject to refund, the MISO Day 2 costs. In compliance with this Order and the required "net" accounting of Day 2 costs and revenues, we have included in the September FCA, the net MISO Day 2 costs for July 2008 as recorded in Account 555. The MISO Day 2 cost recovery included in this September FCA is \$33,077,597, which is the net of many items. Pursuant to the above mentioned Order, the Company also provides in Exhibit 1, which contains more detailed records supporting the calculation of the MISO costs included.

Attached is the calculation of the September FCA, as well as a statistical summary of energy sources and costs, compared to the previous month.
