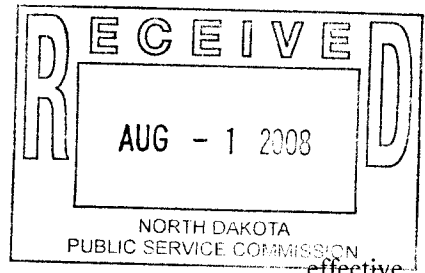


INCREASE RIDER
