**RE: Grain Warehouse License**

Dear Travis:

Enclosed is your North Dakota Grain Storage Warehouse License for Eldridge, Cleveland, and Windsor and relevant documents. Your license and each of the colored posters must be displayed at your facilities in an area easily visible by patrons.

State law requires that licensees submit grain movement and storage reports. Enclosed is an original form that we ask you to use for making copies when submitting your monthly reports. State law requires that these reports be submitted within 30 days of the end of each month.

The grain movement number for Eldridge will remain **1705** and the grain movement number for Cleveland and Windsor will remain **6345**. Please use these numbers on all your monthly report forms. All report forms are mailed to the Upper Great Plains Transportation Institute for input in a database. Legislation makes the information contained in these reports **CONFIDENTIAL**. Information on individual licensees cannot be released to non-governmental entities without the permission of the licensee.
