Dear Peggy and Suzanne:

We have received and reviewed project correspondence and documentation for **08-1277b**: "Robinson Lake: A Class III Intensive Inventory for a Proposed Pipeline Corridor in Mountrail County, North Dakota," (Ed Stine and Aaron Barth, MAC, December 2008) and find it acceptable. We concur with the scope and level of identification efforts for the project. The management recommendations regarding site avoidance strategies for unevaluated-undetermined sites are acceptable as specified in the text (pp. 36-38) and as listed in Table 1. We concur that the six (6) isolated finds listed in Table 1 are not significant and are not eligible for listing in the National Register of Historic Places. Likewise, we concur that the seven (7) historic sites/components described and listed in Table 1 are not significant and are not eligible for listing in the National Register of Historic Places. We concur with "**No Historic Properties Affected**" and "**No Significant Sites Affected**" determinations provided the project is of the nature stated and it takes place in the location described and plotted in the project documentation.
