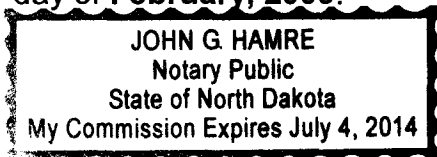

**ORDER GRANTING PETITION TO INTERVENE**

**February 11, 2009**

On December 30, 2008, Richard J. Savelkoul, Attorney for Felhaber, Larson, Fenlon & Voight, P.A., filed a petition on behalf of Goodrich Corporation, Cargill Corporation, Cavendish Farms, Inc., Archer Daniels Midland Company, ComDel Innovation and Tharaldson Ethanol LLC, (North Dakota Large Industrial Group or Large Industrial Group) to intervene in the captioned proceeding.

The petition states that members of the Large Industrial Group are ratepayers of Otter Tail Corporation (Otter Tail) that may be adversely affected by the proposed increase in rates and have a substantial interest in this proceeding. The petition states the Large Industrial Group will present evidence relevant to the rate case.


The Commission finds that each member of the Large Industrial Group has an interest in this matter and its participation will not unduly broaden the issues or delay the proceeding,
