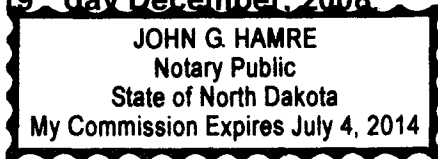

ORDER REVOKING AUCTION CLERK LICENSE

December 17, 2008


Melanie Jane Zimbelman dba Zimbelman's Gifts, Granville, North Dakota holds auction clerk license number 595 issued by the Public Service Commission under the provisions of NDCC Chapter 51-05.1.


On October 6, 2008, the Commission was notified that the bond issued to Melanie Jane Zimbelman dba Zimbelman's Gifts would be cancelled effective December 6, 2008. NDCC Chapter 51-05.1 requires that auction clerks maintain adequate bond coverage and provides that the Commission, without hearing, shall revoke the license effective the date the bond is cancelled unless a new bond is filed or notice to reinstate the cancelled bond is received. No bond or reinstatement was filed and auction clerk license number 595 issued to Melanie Jane Zimbelman dba Zimbelman's Gifts is revoked.

Order

The Commission orders that auction clerk license number 595 issued to Melanie Jane Zimbelman dba Zimbelman's Gifts is revoked as of December 6, 2008. Melanie Jane Zimbelman dba Zimbelman's Gifts can no longer clerk at public auction under auction clerk license number 595 and auction clerk license number 595 shall be surrendered to the Commission immediately.
