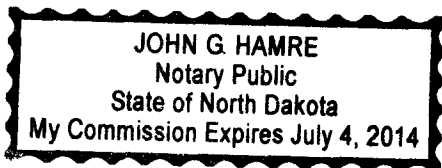

On November 25, 2008, Saddle Butte Pipeline LLC filed an application for a Certificate of Public Convenience and Necessity to construct and own a natural gas and crude oil pipeline system in McKenzie and Dunn Counties.
