**NOTICE OF RECEIPT OF RENEWAL AND REVISION APPLICATIONS**

The Coteau Properties Company has filed applications to renew and revise Surface Coal Mining Permit No. NACT-0201 covering lands located in:

All or portions of Sections 2, 3, 4, 5, 6, 7, 8, and 9 of T144N, R88W; Sections 1 and 12 of T144N, R89W; Sections 30, 31, and 32 of T145N, R87W; and, Sections 3, 4, 9, 10, 11, 14, 15, 16, 21, 22, 23, 25, 26, 27, 28, 33, 34, 35, and 36 of T145N, R88W, of Mercer County, North Dakota, containing 17,050.96 acres.

The five-year permit renewal will allow Coteau to continue to operate within the existing permit area until April 14, 2014. The revision application identifies the next five-year coal removal area. The revision also updates other information in the permit including surface and mineral ownership, business entity and compliance information, surface and ground water information, soils resources information, operations, and reclamation, transportation and surface water management plans, and post-mining land use plans. This revision includes design plans for five additional sediment ponds that will be constructed in 2009. You may submit written comments or objections on the proposed permit renewal its effects on the environment and on surface owners of the land in the permit area. You may request an informal conference with the Commission and the applicant on the renewal and revision applications. The reasons for requesting an informal conference must be stated in the request. Written comments, objections, or requests for informal conference must be made by March 16, 2009.

If there is an informal conference, you may request a formal administrative hearing on the Commission ruling on the application. Your request for a formal hearing must be made within thirty days of the Commission ruling on the application.
