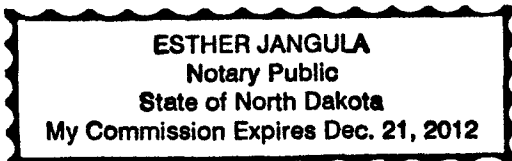

ORDER REVOKING AUCTION CLERK LICENSE

February 25, 2009


Robin Solheim dba Solheim Auction & Clerking, Williston, North Dakota holds auction clerk license number 562 issued by the Public Service Commission under the provisions of NDCC Chapter 51-05.1.

On December 12, 2008, the Commission was notified that the bond issued to Robin Solheim dba Solheim Auction & Clerking would be cancelled effective February 18, 2009. NDCC Chapter 51-05.1 requires that auction clerks maintain adequate bond coverage and provides that the Commission, without hearing, shall revoke the license effective the date the bond is cancelled unless a new bond is filed or notice to reinstate the cancelled bond is received. No bond or reinstatement was filed and auction clerk license number 562 issued to Robin Solheim dba Solheim Auction & Clerking is revoked.

Order

The Commission orders that auction clerk license number 562 issued to Robin Solheim dba Solheim Auction & Clerking is revoked as of February 18, 2009. Robin Solheim dba Solheim Auction & Clerking can no longer clerk at public auction under auction clerk license number 562 and auction clerk license number 562 shall be surrendered to the Commission immediately.


